- 45 Repeat. The small cooler beneath the grill is not working. Need to replace split gaskets. Counters and cabinets are damaged. Shelving in the walk-in cooler is rusty-recommend trying to clean it, but if the rust won't come off shelving will need to be replaced. The white freezer is residential and is not approved for commercial use. The crock pot for the nacho cheese is residential.
- 47 Repeat. More thorough equipment cleaning is needed. Shelving, cabinets, outsides of equipment.
- 51 0-pts. The toilet in the men's room needs cleaning.
- 52 Repeat. Cleaning is needed around the dumpster area. The can wash is clogged and needs cleaning.
- 53 Repeat. Repairs need to be made of floors, walls and ceilings. Cleaning is needed through out kitchen.
- 54 0-pts. One of the light fixtures in the walk-in cooler is damaged and the bulb is exposed. Need to replace the shield or the fixture.
