- 37 3-305.11 Food Storage-Preventing Contamination from the Premises - C Repeat: One box of frozen beef on sheet pan under shelf in walk in freezer. Foods must be kept at least six inches off the floor at all times. Do not store foods on floor or under six inches from the floor.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repeat: Metal plate has gaps and one plate is missing from the front of the three compartment sink. Replace and reseal plates to cover gaps between sink basins. Equipment shall be kept in good repair.
- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - C REPEAT: Grout worn down in warewashing and cooking area of the kitchen. Continue to repair grouting where needed. Wall damage present around three compartment sink and hand washing sink with missing tiles and drywall, continue repair work. Baseboard peeling off wall in downstairs kitchen. // 6-501.12 Cleaning, Frequency and Restrictions - C Cleaning needed under ovens and deep fryers to remove food debris and soiling. Cleaning needed in areas with thin or chipped grouting to remove food debris from between tiles.
