- 14 4-601.11 (A) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - P - Repeat - Approximately 10 metal trays had visible residue/grease on them and buffalo chopper had visible cabbage residue on the blade and housing. Food-contact surfaces of equipment and utensils shall be cleaned to sight and touch. CDI - Items taken back to be rewashed.
- 21 3-501.17 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Date Marking - PF - Repeat - Package of ham was not dated in small make-unit and a large container of baked beans in walk-in cooler was prepared 7-8 and had yet to be discarded. Potentially hazardous ready-to-eat foods shall be date marked if held for at least 24 hours and the food must be discarded 7 days from preparation, with day 1 being the date of preparation. CDI - Baked beans and ham discarded.
