Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.



- 45 Repair or replace the damaged / rusting front service / hot holding unit. The pot rack above the 3 compartment sink does not meet ANSI / NSF standards. All equipment must meet ANSI / NSF standards. Remove it.
- 47 Cleaning is needed on: the exterior of cook line equipment, the interior and door gaskets of refrigeration units, and the shelving.
- 48 The hot water temperature in the facility at the time of this inspection was 115 F. The required hot water temperature is 130 F. The water heater was adjusted by the manager and all issues were resolved.
- 51 Properly seal all areas and enclose pipes in the restrooms so that they are smooth and easily cleanable.
- 53 Extensive floor repair is needed throughout the facility. Cleaning is needed on the floors below equipment and shelving along base boards and in corners.
- 54 Lighting levels in both restrooms are too low ranging from 7 Ftc to 10 Ftc. The required lighting level for these areas in 20 Ftc.
