- 51 Properly seal all areas and enclose pipes in the restrooms so that they are smooth and easily cleanable.
- 53 Extensive floor repair is needed throughout the facility. Cleaning is needed on the floors below equipment and shelving along base boards and in corners. Replace the damaged door sweep on the rear door in the cook line area. Wall repair is needed in the dry storage room. Repair the holes in the wall adjacent to the old ice machine area.
- 54 Lighting levels in the men's restroom are too low ranging from 7 Ftc to 10 Ftc. The required lighting level for these areas in 20 Ftc.
