1 0-pts. Starting January 2014 it will be mandatory for the person in charge to be servsafe certified.



14 The hot water for sanitizing was not hot enough while it was being used to sanitize utensils. The first time it was checked it was 132F, the second time 162F. Hot water for sanitizing must be at least 170F. The booster heater was not getting hot enough. It was removed and the sink was set up for chemical sanitizing (50ppm Chlorine) until the booster can be repaired.

20 Cut lettuce was in a pan on the cutting board of the make unit 59-62F (product was voluntarily disposed of). Compound butter 56F. There foods are taken out of the cooler during lunch time and are getting off temp. Potentially hazardous foods must be kept cold at 45F or below. Keep these food items in a cooler or on an ice bath or used time in lieu of temperatures to limit bacteria growth.

The make unit is running warm with an air temp of 42F, but the food in the top of the make unit 47 to 50F. Ham 47F, boiled eggs 50, provolone 48, shredded cheese 50F. The cooler should have an internal air temp of 38-40 to keep food at 45 and below.

- 45 Need to replace several torn refrigeration gaskets and chipping/rusty shelving in the upright coolers. The lids for the pizza make unit are missing hinge pieces.
- 51 0-pts. There needs to be covered waste receptacle in the women's restroom.
- 53 Need to clean beneath the ovens and around legs of equipment. There are stained ceiling tiles in the wait station. Need to reattach the base boards by the pizza oven. The tracks for the ceiling tiles in the back are rusting.
