

- 4 2-401.11 Eating, Drinking, or Using Tobacco - C. Three employee beverages were sitting on food prep surfaces. Employee beverage must be kept in cups with lids and straws stored below food contact surfaces. CDI-employee beverages were disposed of.
- 6 2-301.12 Cleaning Procedure - P. Observed employee using bare hands to turn off handsink. Need to use papertowels to turn off the water after drying hands. CDI-employee re-washed their hands.
- 14 4-601.11 (A) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - P. Several cleaned pans had food debris on them. The bin used for boberry biscuits needed cleaning. There was build-up on the soda and tea nozzles. Need to clean and sanitize food contact surfaces more thoroughly. CDI-utensils and drink nozzles were cleaned and sanitized.

## Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.



- 16 3-401.11 Raw Animal Foods-Cooking - P,PF. Repeat. Raw chicken cook temps 135F-154F. The large pieces of chicken not getting cooked to the required 165F. CDI-the chicken was recooked to 170-203F.
- 36 6-501.111 Controlling Pests - PF. 0-pts. There were two flies in the mens restroom. Need to work on pest control.
- 42 4-901.11 Equipment and Utensils, Air-Drying Required - C. 0-pts. There were around three pans with water stacked beneath them. Allow pans to air dry before stacking.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C. There is a leak beneath the condenser drain in the walk-in freezer. Do not store food beneath the leak until it is repaired. The biscuit cooler was not maintaining temp, air temp 48F. The only PHF in the cooler is butter milk (47F). Be sure to keep the buttermilk in another cooler until it is repaired.
- 47 4-602.13 Nonfood Contact Surfaces - C The shelving in the chicken walk-in cooler, outsides of equipment, near the grills, hoods over the biscuit oven, inside of the biscuit cooler were soiled and need cleaning. Need to clean equipment more thoroughly.
- 53 6-501.12 Cleaning, Frequency and Restrictions - C 0-pts. The floors, walls, and ceilings have flour and some grease build-up on them. Need to clean floor walls ceiling more thoroughly.
- 54 .6-202.11 Light Bulbs, Protective Shielding - C. 0-pts. The tube shield on the light fixtures in the chicken walk-in cooler were missing end caps. The light shield in the walk-in freezer is cracked. The bulbs are burned out in one of the fixtures in the walk-in freezer.
