- 41 3-304.12 In-Use Utensils, Between-Use Storage - C 0 points. Bucket for ice scoop storage had minor amount of debris in bottom. Store in-use utensils in a clean, dry place, in food with handles out, in 135F or greater water or in running water which quickly moves food particles to the drain.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repeat violation. Replace rusted racks and shelf brackets inside upright refrigerator. Recondition cabinets in self service area to be smooth and easily cleanable. Realign sneeze guard where it has fallen on one side. Equipment shall be in good repair.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C 0 points. Minor cleaning needed in self service microwave. Non food contact surfaces of equipment shall be clean.

- 52 5-501.113 Covering Receptacles - C 0 points. One dumpster door observed open. Keep dumpster and other outside waste handling containers for refuse, recyclables, and returnables covered with tight-fitting lids or doors.
- 53 6-501.11 Repairing-Premises, Structures, Attachments, and Fixtures-Methods - C Repeat violation. Repair damaged floor tiles and floor/wall junction in back prep room. Caulk holes in ceiling above 3 compartment sink. Repair cracked laminate on right side of hot dog prep counter. Remove tape from outlet in ladies restroom. Physical facilities shall be in good repair.
- 54 6-303.11 Intensity-Lighting - C Repeat violation. Lighting low at back prep table (20 footcandles). Increase lighting to 50 footcandles at food prep areas.
