- 4 There was an employee beverage in an open cup sitting on the prepsink while food was being prepared. There was also an open cup with unidentified fluid similar to oatmeal above the prep sink. Employee beverages must be kept in cups with lids ad straws stored below all food contact surfaces.
  
- 6 Observed employee rinse hands in the prep sink, dry hands on apron then start preparing food. Hands must be washed using soap and warm water for at least 20 seconds in a hand sink. Then dry hands on a paper towel.

- 7 Observed employee slicing gordita bread, and another handling cut radishes with bare hands. there should be no bare hand contact with ready to eat foods, gloves, utensils, deli papers can be used.
- 13 There was a pot of meneudo on the floor and was poured into another container on the floor later during the inspection. Do not prep food on the floor. There was a box of jalapenos and a box of avocados on the floor in the dry storage room. Keep food off of the floor.
- 20 0-pts. There were a couple packs of ham and a pack of hot dogs measuring 53F in the make unit. The other foods in this cooler were 45F and below. Recommend checking this cooler regularly, adn be sure foods are left out too long during prep/rush times.
- 26 There were several unlabeled chemical bottles. All chemical bottles must be labeled. A bottle of degreaser was hanging on the shelving above the meat prep sink. Keep all chemicals stored below food contact surfaces.
- 37 0-pts. Need to be more careful with food handling. Make sure the food is safe from delivery to service.
- 39 0-pts. Several cloths were on the counters. In use wiping cloths need to be kept in sanitizer between uses.
- 41 0-pts. The knife used to slice the gorditas was kept in water. In use utensils need to be kept on a clean dry surface.
