- 23 3-603.11 Consumption of Animal Foods that are Raw, Undercooked, or Not Otherwise Processed to Eliminate Pathogens. 0-pts The menu features a reminder portion of the consumer advisory, but need a disclosure of specific items that are served under cooked. Example would be to put asterisks by Huevos rancheros, steaks, and ceviche (disclosure) then tie the items to the reminder that lets customers know the risks of consuming undercooked food.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment. The grater needs to have hinges and latch replaced with food equipment grade fasteners. Need to seal the gap between the ice machine and ice bin. There is a small leak beneath the utensil sink.
