Equipment, food contact surfaces and utensils shall be clean to sight and touch. CDI- all items were sent to be rewashed.// 4-602.11 Equipment Food-Contact Surfaces and Utensils-Frequency - (P)- additional cleaning required inside dishmachine. Equipment, food contact surfaces and utensils shall be cleaned as often as necessary to prevent accumulation of debris.
- 21 3-501.17 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Date Marking - (PF)- REPEAT- Multiple items such as cooked noodles, ramen, and several containers of sashimi fish were not dated with date of prep or date of discard. Ready to eat foods shall be labeled with the date of preparation or date of dsiposition. CDI- PIC labeled all items with their proper date.

- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - REPEAT- torn gasket on reach in cooler. Replace plug that is missing from sushi display case. Repair/ replace racks beginning to rust. Repair/ replace large dent in vegetable make unit that is discolored. Equipment shall be maintained in a state of good repair.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - REPEAT- additional cleaning along dry storage shelving and walk in cooler racks as well as sides of fryers and make units where grease and other debris has built up. Non-food contact surfaces shall be cleaned at frequency to prevent accumulation of soil residue.
- 53 6-501.12 Cleaning, Frequency and Restrictions - REPEAT- additional cleaning required on wall near sushi display case. All physical facilities shall be maintained in good repair and shall be cleaned as often as necessary to keep them clean and by methods that prevent contamination of food products.
