

- 18 3-501.14 Cooling - P One 5 # beef roast was cooling tightly wrapped in plastic wrap. Temperature of roast was 58 degrees F after being in walk in cooler for 11 hours. All hot food must be cooled properly before placing in the walk in. Manager will train employees on cooling
- 31 3-501.15 Cooling Methods - PF The proper way to cool a whole roast is to cool rapidly from 135F to 70F using an ice bath and steel pans. When cooled to 70F the roast may be placed in the walk in to cool from 70F to 41 or below in 4 hours. When placed in cool holding equipment food containers in which food is being cooler shall be; arranged in the equipment to provide maximum heat transfer through the container walls and Loosely covered or uncovered if protected from overhead contamination during the cooling period to facilitate heat transfer from the surface of the food. Manager will train employees
- 42 Need to store forks up handles up in silver ware baskets. Need to work with staff to air dry steel and plastic pans before drying.
 4-901.11 Equipment and Utensils, Air-Drying Required - C
 4-904.11 Kitchenware and Tableware-Preventing Contamination - Knives ,forks, and spoons that are not pre wrapped shall be presented so that only handles are touched by employees and by consumers if consumer self service is provided.
 4-904.11 Kitchenware and Tableware-Preventing Contamination - C Do not store ice wands on the floor in the walk in freezer, cleaned sanitized during inspection. Manager talked to dish washer about placing fork with handle up when washing.

Need to clean and sanitize on a regular basis. Equipment food-contact surfaces and utensils shall be clean to sight and touch. Soda guns cleaned during g inspection . Manager stated he would have ice machine cleaned at end of business as soon as possible.
- 54 4-204.11 Ventilation Hood Systems, Drip Prevention - C Need to clean the hood at the dish machine; observed build up around vent to day.
