- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P - Half mini pan of shredded cheese not holding temp - recorded at 49 deg F - all cold holding items must be held no more than 45 deg F - make sure to store pans submerged in ice instead of just above ice to ensure items are maintained to 45 deg F

- 21 3-501.17 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Date Marking - PF - A couple of pans of mashed potatoes and turkey labeled by date of preparation - under new rules, when date marking potentially hazardous, ready to eat foods held over 24 hours, items must be date marked by date discarded or consumed
- 34 4-302.12 Food Temperature Measuring Devices - PF - Missing thermometer in lower make unit coolers - make sure to have a thermometer in all coolers and freezers; Also, facility checks temps with surface temp thermometer (laser thermometer) - must have, at minimum, a metal stem thermometer, accurate to within two degrees F and ranging from 0 - 220 deg F
- 35 3-602.11 Food Labels - PF - Unlabeled bin of salt in back - make sure to label dry goods bins
- 37 3-305.11 Food Storage-Preventing Contamination from the Premises - C - Ice bin for soda fountain in front station left open during inspection - make sure to shut ice bin lid when not in use
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C - Replace rusty storage racks and rack supports; Have Coke replace/repair switch on ice bin lid of soda fountain so when lid is opened, machine shuts off
- 47 4-602.13 Nonfood Contact Surfaces - C - Detailed cleaning needed under lips of countertops and on and around equipment - some slight cleaning needed on storage racks in dry goods area
- 49 5-203.14 Backflow Prevention Device, When Required - P - Tea and coffee makers require dual check valve on water supply to urns/coffee makers to ensure no backflow hazard exists - attach at water supply line or in case of water supply feeding two devices, add before water line splitter to service both machines
