

- 4 2-401.11 Eating, Drinking, or Using Tobacco - C A cup with a few ice cubes on a work table could not determine if it was an employee cup or not. Other cups were in on a bottom shelf with lids and a straw. Manager will review employee drinks with staff.
- 14 4-602.11 Equipment Food-Contact Surfaces and Utensils-Frequency - P The blue ice scoop holder on the wall at the ice machine needs to be cleaned and sanitized on regular basis. Black build up found in bottom of ice scoop holder today.
- 39 3-304.14 Wiping Cloths, Use Limitation - C A soiled wiping cloth was observed on a splash guard of a hand sink. Wiping cloths are for wiping food spills only and shall be maintained dry and used for no other purpose. Cloths in -use for wiping counter and other equipment surfaces shall be Held between uses in a chemical sanitizer solution at a concentration specified under 4-501.114and laundered daily as specified under 4-802.11(D).
