


- 31 3-501.15 Cooling Methods - PF: A pan of overstacked tomatoes on the sandwich line measured at 51 F. Cooling shall be accomplished in accordance with time and temperature by placing the food in shallow pans, separating the food into smaller or thinner portions, using rapid cooling equipment, stirring the food in a container in an ice bath, using containers that facilitate heat transfer, adding ice as an ingredient, or other effective methods. CDI: PIC was educated on cooling alternatives. PIC discarded tomatoes.
