One wiping cloth observed on shelving beside vegetable sink. Wet wiping clothes are to be store in sanitizer when not in use. Both items were CORRECTED.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Stainless steel shelves in back have rust on support legs. Continue replacing.
