- 19 3-501.16 (A)(1) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P Cooked breaded chicken sitting out in kitchen was 95F. Keep foods hot at 135 or above or cold at 41F or below, do not leave food sitting out at room temperature. CDI - chicken was discarded.
- 37 3-305.11 Food Storage-Preventing Contamination from the Premises - C 3 containers of raw chicken stored on floor of walk-in cooler. Food shall be protected from contamination by storing the food in a clean, dry location where it is not exposed to splash, dust, or other contamination and at least 6 inches above the floor.
- 39 3-304.14 Wiping Cloths, Use Limitation - C Towel bucket contained sanitizer and soapy water. Cloths in use for wiping counters and other equipment surfaces shall be held between uses in properly mixed sanitizer; do not mix soap and sanitizer together. CDI - bucket refilled with water and CI sanitizer only.
