- 45 GC: Caulk in between the splash guard and handwash sink, at the drive through, has peeled away. Caulk in between the splash guard and the prep sink, next to the hot water urns, is peeling away. Recaulk.
- 46 4-603.16 Rinsing Procedures - C - GC: Employee observed washing soda nozzles and then place them in sanitizer. After thoroughly washing, equipment and utensils must be rinsed with running water in order to remove abrasive and cleaning chemicals. CDI- Employee rewashed, rinsed, and then sanitized nozzles.
- 47 Equipment cleaning is necessary on: all green shelves in the facility, in the cabinet underneath the grills, and high shelving.
