PIC states that these items were removed from freezer Friday. Potentially hazardous food held in the facility 24 hours or more shall be properly marked to indicate the discard date. Be sure, if food is frozen, to indicate the date it was removed from freezer. CDI. Items discarded.
- 42 4-901.11 Equipment and Utensils, Air-Drying Required - C Several stacks of metal pans on clean dish rack stacked wet. Air dry equipment and utensils after cleaning and sanitizing.

In food service establishments in which cleaning methods other than water flushing are used for cleaning floors, the floor and wall junctures shall be coved and closed to no larger than one thirty-second inch (1 mm).
