- 37 3-306.11 Food Display-Preventing Contamination by Consumers - P Apples on display without cover on service line. Ready to eat food shall be covered by either individual wrappings or sneeze guard. Apples covered to prevent contamination.
- 43 4-904.11 Kitchenware and Tableware-Preventing Contamination - C Paper cups stored in metal dispenser without cover on top. Single service and single use articles shall be stored in a way to prevent food and lip contact surfaces from contamination. Use cover on top of cup dispenser.
