- 13    3-302.11 Packaged and Unpackaged Food-Separation, Packaging, and Segregation - Although sneeze guard was in place for milk and water containers, items were still exposed - try moving condiments container at back of sneeze guard so water and milk containers are properly covered by sneeze guard and make sure to lower sneeze guard slightly as to provide adequate protection - manager moved water and milk to back area
- 19    3-501.16 (A)(1) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - Oatmeal out of temp - all hot holding items must be held at a minimum internal temp of 135 deg F - since item was placed out at 4 am, manager threw oatmeal away
- 21    3-501.17 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Date Marking - All potentially hazardous, ready to eat items must be properly date marked by date prepared and date consumed/discarded and held no more than 4 days if held at 45 deg F or 7 days if held at 41 deg F or less
