- 13 3-302.11 Packaged and Unpackaged Food-Separation, Packaging, and Segregation - P - Raw steaks in packaging were stored with packaged salami and sausage. Store food in accordance to its final required cook temperature. CDI- Food storage was reorganized to eliminate cross contamination risk.
- 35 3-302.12 Food Storage Containers Identified with Common Name of Food - C - Bottles storing water, oil, and Greek dressing are unlabeled. Working containers holding food or food ingredients shall be labeled with the common name of the food.
- 36 6-202.13 Insect Control Devices, Design and Installation - C - Insect control device is installed directly above single service items and bottled food. Insect control devices shall be installed so that they are not located over food preparation areas and dead insects are prevented from falling on exposed food, clean equipment, utensils, and linens, and single service articles. Relocate the device. / 6-501.111 Controlling Pests - PF - A fly was observed in the establishment. The premises shall be free of pests.

- 41 3-304.12 In-Use Utensils, Between-Use Storage - C - Five pairs of tongs were stored on the handle of the oven. Store in use utensils in the food with their handles above the top of the food and the container, on a clean portion of the food preparation table or cooking equipment, in running water of sufficient velocity to flush particulates to the drain, or in a container of clean water maintained at a minimum of 135F. CDI- PIC placed tongs on a sheet pan.
- 45 Equipment repair is necessary on: torn gaskets on True two door reach in cooler, condensor cover in pizza reach in cooler, oven door that falls open and held in place with duct tape, and cutting board on make top unit is wearing. / Evian beverage cooler is only approved for the use of packaged and bottled products. Discontinue storing pasta salad, rice, and other food items that are not packaged or bottled.
- 47 Equipment cleaning is necessary on: all shelves in the walk in cooler, shelf above the Pepsi beverage cooler, gaskets in reach in units, the sides of grills and fryers, and underneath the pizza oven.
- 53 Floors: Floor cleaning necessary underneath upright freezers and behind large equipment. / Baseboard peeling away at the back door of the establishment.
Walls: Wall cleaning necessary above the Pepsi beverage cooler. / Wall repair necessary at the handwash sink in the women's restroom.
