- 35 Label all dry food containers, cooking oils, etc. not in original container.
- 36 Couple of flies noted today. Check with PCO for treatment options.
- 38 Beard restraints are required, if working with food. Plain band (such as wedding band) is only jewelry allowed, if working with food (no bangles or watches on wrists allowed)
- 39 Wet wiping cloths need to be stored in sanitizing between uses. Bucket or container should be labeled and sanitizing solution changed on regular basis.
- 45 Leaky faucet on produce prep sink.
- 47 Clean oven, etc.
- 51 Need covered receptacle in women's bathroom for disposal of sanitary napkins.
