- 43 Single-use cups either need to be properly protected by a dispenser of kept in the original sleeve and work out of the sleeve.
- 45 Currently the hand wash sink is not providing proper water pressure.
Hands are being washed in an adjacent dump sink with access to soap and paper towels. Smoothie pitchers will be dumped and rinsed in the rinse vat of the three compartment sink.
Smoothie make unit is leaking onto the floor and needs to be checked out.
- 47 Detail cleaning needed on the shelving units around and under microwaves and ovens.
Some cabinet cleaning under the soda fountain machine.
Reminder to remove stickers and residue before and during wash food storage containers.
