Clean and sanitize more often. Cleaned during inspection. Potato fry chopper needs extra cleaning. ✓ Spell
- 49 5-202.13 Backflow Prevention, Air Gap - P - Air gap must be provided between the water supply and the flood rim of the sink. The spray nozzle at the 3 compartment sink was in the rinse compartment upon arrival (no water in compartment). Hose does not allow for air gap to be maintained.  
 5-202.14 Backflow Prevention Device, Design Standard - P - Backflow prevention device must be installed specific to the device. No backflow installed.  
 Will plan to change spray nozzle to standard sprayer to achieve air gap or install pressurized backflow preventer.
- 52 5-501.15 Outside Receptacles - C - Waste receptacles shall have tight fitting lids and doors. Doors open on dumpster. Keep doors closed.
