- 8 One hand wash sink in kitchen had a steel scrub pad in bottom of sink. Hand sink in bar was being used to soak multiuse plastic bottles used in bar. As the signs posted on each hand wash sink states these sinks are for hand washing only. The soap dispenser at the hand sink at the bar was not dispensing soap, fix as soon as possible. Use a pump bottle of soap to wash hands as the dispenser is repaired. 5-205.11 Using a Handwashing Sink-Operation and Maintenance

- 20 Tomatoes were 50 degrees F in the walk in salad cooler, milk was 45F, and the iceberg lettuce was 46degrees F. All PHF/TCS must be 45F or below. 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding
- 45 A few gaskets need to be replaced. Need to have salad cooler repaired as soon as possible. There is a condensate leak in the walk in freezer, repair as soon as possible. Ice is on floor and on pipes to unit.
