- 14 No sanitizing solution was provided at the 3 compartment sink at the time of this inspection. When using quaternary ammonia as a sanitizing solution its strength must be maintained between 200 ppm and 400 ppm. Detailed cleaning is needed on the interior of the ice machine and the drink machine nozzles.

- 20 Three containers of pupusas filling (50 F) were found in the make unit off temperature. All food items being held cold must be held at or below 45 F. The Pupusas were moved to a properly working refrigeration unit.

- 45 The reach in cooler / make unit on the cook line was not working properly at the time of this inspection. All food items were moved to a properly working refrigeration unit. A repair person was called. Contact M. Craig Faircloth with FCHD at 703-3166 when needed repairs have been made.
- 46 The sanitizing solution dispenser at the three compartment sink was not working properly at the time of this inspection. The sink was switched from quaternary ammonia to chlorine based sanitizer temporarily until the system is repaired.
