- 45 0-pts. There is some ice buildup on the condenser in the walk-in freezer.
- 47 Equipment cleaning is needed. Examples include the inside of the toastmaster warmer, condiment bins, handles of equipment, outsides of equipment.
- 53 Repeat. Need to seal the piping/conduit penetrations in the ceilings. The hoses and wires beneath the service counter need to be in chase/wrapped so they are easily cleanable. Need to install a coved base board beneath the service counter. There is standing water in a wash pit behind the grease bin, be sure to unclog the drain. Need to replace any cracked floor tiles. Floors and walls need cleaning.
