- 4 2-401.11 Eating, Drinking, or Using Tobacco - Open employee drink stored on pass through ledge and other employee drink stored on top storage rack in lower make unit above food - employee drinks must be stored with a tight fitting lid and below any food contact/prep areas - this includes pass through ledges above grill and make unit and on racks above food - manager threw drinks away
- 8 5-205.11 Using a Handwashing Sink-Operation and Maintenance - Handsink near three compartment sink and in men's restroom did not have paper towels present - handsinks must be stocked and available to use during hours of operation - manager placed paper towels at handsinks

- 14 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - Sanitizer too strong - did not register on test strips - must be between 50 - 100 ppm if using chlorine/bleach solution - remade sanitizer so it is now 100 ppm
- 26 7-101.11 Identifying Information, Prominence-Original Containers - Unlabeled bottles of sanitizer and bleach for wall cleaning - make sure all chemical bottles are labeled according to contents - manager labeled bottles
7-201.11 Separation-Storage - Bottle of sanitizer stored on drain board of prep sink and bottle of soap stored on storage rack above food in rear - all chemicals must be stored below or away from any food contact/prep areas - this includes drain boards - manager moved bottles to proper location, below prep areas
- 38 2-303.11 Prohibition-Jewelry - Observed manager cook food with watch and ring on wrist/finger - under Food Code, nothing, other than a smooth wedding band, can be worn on hands/arms during food prep
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - Cracks still present at corners of basin in three compartment sink - have rewelded and smoothed down so no bacteria/debris can collect; Torn cooler/freezer gaskets - have replaced; Reach in freezer broken - replace compressor so freezer operates under manufacturer's specifications; Recaulk splash guard on three compartment sink handsink as it is starting to tear; Repair leak on faucet handle of three compartment sink
- 46 4-302.14 Sanitizing Solutions, Testing Devices - Must use test strips to check strength of sanitizer
- 47 4-602.13 Nonfood Contact Surfaces - Detailed cleaning needed on storage racks in walk in cooler
- 52 5-501.15 Outside Receptacles - Dumpster lid open - make sure to shut dumpster lids when not in use as to help prevent pest and rodent harborage
5-501.16 Storage Areas, Rooms and Receptacles, Capacity and Availability - Trash can not adjacent to front handsink - may want to either move trash can near register or add trash can near handsink
