Knives and magnetic knife holder had steel bits from a scrubbie stuck to them. Food shall be protected from contamination. CDI- Placed sheet pan under ice build up until repaired. Knives and magnet were washed.
- 39 3-304.14 Wiping Cloths, Use Limitation - C -Wiping cloth in soapy water bucket. Once wet, wiping cloths shall be stored in an effective sanitizing solution. Opts.

Knives, forks, and spoons that are not prewrapped shall be presented so that only the handles are touched by employees and by consumers, if self service is provided.
