- 14 4-702.11 Before Use After Cleaning - P quat sanitizer was too weak, measuring 100 ppm with test strips. Per test strips, the testing solution should be between 65-75F; be sure you are correctly testing the sanitizer to ensure that your reading is accurate. CDI - more quat tabs added to sink, strength was re-checked and was 200 ppm by end of inspection; sani buckets were re-filled. ✓ Spell
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P lettuce in cold well was 41-49F depending on where it was temped. Sliced tomatoes in ref. drawers were 42-45F. All potentially hazardous foods must be maintained at 41F or below. CDI - 45F tomatoes placed back in walk-in cooler to chill to 41F. Discussed option of using time as a public health control for lettuce; lettuce was marked with time today as a temporary fix, and manager agreed to develop a written procedure going forward.
- 34 4-204-112 Temperature Measuring Devices-Functionality - PF Prep cooler is missing a thermometer. Cold holding equipment used for potentially hazardous food shall be equipped with at least one integral or permanently affixed temperature measuring device that is located to allow easy viewing of the device's temperature display. Ensure that all coolers have thermometers.
