- 11 3-202.15 Package Integrity - PF -3 dented cans detected. Food packages shall be in good condition and protect the integrity of the contents. CDI-Removed dented cans, asked manager to look through the remainder of cans and put a system in place for the segregation of cans in the future. Opts.
- 14 4-602.11 Equipment Food-Contact Surfaces and Utensils-Frequency - C -Ice machine has black microbial growth around gaskets in inside back of machine. Food contact surfaces shall be cleaned at a frequency to preclude accumulatin of soil or mold. Clean ice machine. Opts.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C -Panini press had accumulation of carbon build on top press and around edges. Food contact surfaces of cooking equipment shall be kept free of encrusted grease deposits and other soil accumulations. Recommend thorough cleaning. Dust build up on top shelf above prep table and on underside of shelf racks and ticket holder at make unit. Four of four canisters holding clean utensils were soiled. Nonfood contact surfaces shall be kept free of dust, dirt, food residue and other debris.

Manager stated these items were moved there last week and she will move them to approved area today. Floors, walls, and ceilings shall be smooth and easily cleanable. Food storage areas are required to have a coved base for ease of cleaning.
