- 14 4-601.11 (A) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - Ice machine needs to be opened up and thoroughly cleaned inside.
  
- 19 3-501.16 (A)(1) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - Fried chicken 120F-150F. Must maintain 135F or above on hot holding. Ranch breeding must be refrigerated or discarded after 4 hours of use.
  
- 34 4-203.11 Temperature Measuring Devices, Food-Accuracy - Calibrate all metal stem thermometers in ice water to 32F. Discard any that are out of calibration adjustable range.
  
- 35 3-302.12 Food Storage Containers Identified with Common Name of Food - Large container of sugar at beverage counter must be labeled as to contents.

- 37 3-303.12 Storage or Display of Food in Contact with Water or Ice - Ice may not be used on chicken after it is placed in plastic covered containers unless the containers drain the melted ice away from the chicken.
- 47 4-602.13 Nonfood Contact Surfaces - Infrequently used pans and utensils need to be regularly cleaned or cleaned and bagged so as not to accumulate a greasy film.
- 49 5-203.14 Backflow Prevention Device, When Required - Can wash needs Y-hose connected at all times. Spray nozzle on hose must either be removed after use, disconnect hose after use, or install dual check valve at Y-hose to meet proper backflow prevention.
- 51 5-501.17 Toilet Room Receptacle, Covered - Ladies restroom must be provided with a covered receptacle.
- 53 6-501.13 Cleaning Floors, Dustless Methods - Floor cleaning needed under equipment, along wall edges, in corners, under ice machine. Rough wall areas around need to be sealed and smooth.
- 54 6-303.11 Intensity-Lighting - Lighting at ice machine area needs to be increased. Reading 6 foot candles - needs to be 20 foot candles.  
6-304.11 Mechanical-Ventilation - Clean air vents in both bathrooms.
