

- 16 3-401.11 Raw Animal Foods-Cooking - P,PF - Chicken strips cooked with temperature range 158F-175F. Few strips that did not meet 165F were discarded.
- 19 3-501.16 (A)(1) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P - Chicken strips previously cooked were at 120F. These were discarded. Precooked egg patties were at 115F. These were placed back in oven to reheat. Hot foods must be placed under temperature control immediately upon removal from the oven or fryer. Temperature must be maintained at 135F or above.
- 26 .7-102.11 Common Name-Working Containers - PF - Spray bottle with unknown product unlabeled. Bottle was emptied. Always label chemical bottles as to contents.

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.



- 37 3-303.12 Storage or Display of Food in Contact with Water or Ice - C - Raw chicken is received in plastic bags in boxes with ice covering. Chicken is removed from the plastic bags and placed in containers with ice on top of chicken with no means of draining the water from melted ice. The water must be able to drain away from the chicken and not accumulate in the bottom of the container. Options are to not use ice, place chicken in bags once placed in containers (make sure bags do not have holes), provide containers with some type of drainage so melted ice water drains away from chicken.
- 38 2-402.11 Effectiveness-Hair Restraints - C - Kitchen employee has beard. Employees shall wear hair restraints such as hats, hair coverings or nets, and beard restraints are now required.
- 46 4-501.19 Manual Warewashing Equipment, Wash Solution Temperature - PF - Wash water at 3 compartment sink was 105F. This must be maintained at a minimum of 110F. Empty sink after finishing wash and refill prior to next batch. Clean all sink vats thoroughly after utensil washing is finished.
- 47 4-602.13 Nonfood Contact Surfaces - C - Shelf over 3 compartment sink, 3 compartment sink faucet and handles, microwave at customer area need cleaning.
- 53 6-501.11 Repairing-Premises, Structures, Attachments, and Fixtures-Methods - C - Floor tiles are broken especially at the fryers. Wall corners and edges are damaged. Smooth surfaces are needed throughout for easy cleaning.
- 54 6-303.11 Intensity-Lighting - C - Lighting at ice machine-storage area is 5 foot candles. Lighting needs to be 10 foot candles. Install a 2 strip fixture may be sufficient.  
6-202.11 Light Bulbs, Protective Shielding - C - Make sure all lights in the kitchen are properly shielded with tubes and end caps that fit and seal.
