Carrot cake with cream cheese icing stored on retail shelf outside of refrigeration unit. Carrot cake from new supplier (license furnished from dept of agriculture). Supplier states that cream cheese icing is made with flavoring and is shelf stable. Label lists cream cheese icing as ingredient. Maintain TCS foods in cold holding at 41F or less. Icing temperature 71F. CDI. 2 slices with cream cheese icing listed as ingredient were discarded. All other cakes non TCS.
- 42 4-901.11 Equipment and Utensils, Air-Drying Required - C Repeat violation. Pans on clean dish rack stacked wet. Allow pans to air dry thoroughly before stacking.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repeat violation. Recondition lower shelves, casters and legs of sinks and prep tables to remove oxidation and grease buildup. Realign panel on upright freezer so that it sits flush with unit. Remove upside down crates used to store food off of floor as they hinder floor cleaning. Equipment shall be in good repair.
