- 35 3-302.12 Food Storage Containers Identified with Common Name of Food - C - GC: Bottles of sour cream and other food ingredients are unlabeled in the reach in coolers. Label all working containers holding food or food ingredients that are removed from their original packages for use in the establishment with the common name of the food.
- 38 2-303.11 Prohibition-Jewelry - C - GC: An employee was observed wearing a bracelet while cooking. While working with food, employees may only wear a plain ring. / 2-402.11 Effectiveness-Hair Restraints - C - Food employees with facial hair were not wearing beard restraints. Food employees shall wear beard guards to prevent their hair from contacting exposed food.
- 39 3-304.14 Wiping Cloths, Use Limitation - C - Repeat Wet wiping cloths were observed on prep surfaces. In between uses, wet wiping cloths shall be held between uses in a chemical sanitizer solution of appropriate strength.

- 41 3-304.12 In-Use Utensils, Between-Use Storage - C - GC: A knife was store in between the make top unit hutch and lid. Store on a clean portion of the prep table. Refer to 3-304.12.
- 45 GC: There are torn gaskets on the reach in make top unit in the kitchen. Replace. The prep table across from the walk in cooler has three small holes. Repair.
- 46 4-501.14 Warewashing Equipment, Cleaning Frequency - C - The dish machine has build up of soil on the spray arms and on the top interior portion above the spray arms. A warewashing machine must be cleaned before use, throughout the day if necessary, to prevent recontamination of equipment and utensils, and if used, at least every 24 hours.
- 47 GC: Equipment cleaning is necessary on: shelving above tortilla chip hot hold cabinet and exposed plumbing.
- 49 5-205.15 System Maintained in Good Repair - P - GC: There is a leak underneath the scrap sink that goes into the floor sink. Repair.
- 53 GC: The stainless steel baseboard at the back entrance needs to be recaulked to the wall.
