- 14 A bottle of sanitizer at the wait station and a bottle of sanitizer at the bar did not measure a visible color change on the test strips. Chlorine sanitizer shall be maintained at 50ppm-150ppm chlorine at all times. CDI- Sanitizer was discarded by the PIC. 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P
- 16 3-401.11 Raw Animal Foods-Cooking - P,PF - GC: Chicken measured 154F at final cook. Chicken must be cooked until a minimum of 165F is reached. CDI- Food employee was instructed to continue cooking chicken. Chicken's final cook temperature was 170F.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P - GC: A pan of shredded lettuce was 67F. Cut leafy greens are potentially hazardous and must be maintained at a maximum of 45F at all times. CDI- PIC discarded lettuce in the trash can and brought lettuce (48F) from the walk in cooler to replace it.

- 23 3-603.11 Consumption of Animal Foods that are Raw, Undercooked, or Not Otherwise Processed to Eliminate Pathogens - PF - Consumer advisory has a disclosure, but it does not have a reminder. A consumer advisory must include a disclosure and a reminder. A disclosure shall include a description of the animal derived foods (ex: steak, can be cooked to order) or identification of the animal derived foods by asterisking them to a footnote. A reminder shall include asterisking the animal derived foods requiring disclosure to a footnote that informs the consumer that items are undercooked and there is an increased risk of foodborne illness.
- 41 3-304.12 In-Use Utensils, Between-Use Storage - C - Scoop handles for beans, rice, and other dry ingredient storage containers were stored in the food. Store handles of scoops above the surface of the food. CDI- PIC stored scoops with the handles above the surface of the food.
- 45 GC: Equipment repair/replacement is necessary on: torn gasket in the reach in cooler in front of the gas stove and the bent leg of the dump sink in the bar.
- 47 Equipment cleaning is necessary on: high shelving throughout the facility (in particular: shelving above chicken prep sink, shelving above seafood prep sink), the top of the cooler drawer unit (underneath the grill), and equipment legs.
- 53 GC: Recaulk along all of the commodes in both restrooms. Caulk is missing or wearing.
- 54 6-303.11 Intensity-Lighting - C - GC: Lighting along the chicken prep sink and prep table is 31-39 foot candles. Increase lighting to a minimum of 50 foot candles in this area. Recommend changing light bulbs.
