## Observations and Corrective Actions

- 13 3-302.11 Packaged and Unpackaged Food-Separation, Packaging, and Segregation - P Food packages in walkin freezer were left open and not closed securely (chicken wings, hush puppies, green peas). Frozen uncooked chicken breast were in a pan waiting to be cooked on the same table where deli meats and produce were being prepped. Foods must be protected from cross contamination by covered containers/wrappings and separate prep areas (or times) for raw meats and ready to eat foods.
- 34 4-203.11 Temperature Measuring Devices, Food-Accuracy - PF Metal stem thermometer was 5 degrees off. FOOD TEMPERATURE MEASURING DEVICES that are scaled only in Fahrenheit shall be accurate to  $\pm 2^{\circ}\text{F}$  in the intended range of use. Calibrate thermometer daily before use to insure accuracy.
- 42 4-901.11 Equipment and Utensils, Air-Drying Required - C Pans were stacked wet on utensil storage rack. After cleaning and SANITIZING, EQUIPMENT and UTENSILS: must be air-dried or used after adequate draining. Additional rolling utensil draying racks could be purchased to provide the rack space needed to air dry the large volume of pans and utensils used.
