- 14 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P - GC: One sanitizer bottle did not show a visible color change on the test strips. Quaternary Ammonia sanitizer strength must be maintained at 150ppm-400ppm at all times. CDI- Sanitizer vat at the three compartment sink was filled with sanitizer and it measured 150ppm. Bottle was refilled using this sanitizer solution.
- 41 3-304.12 In-Use Utensils, Between-Use Storage - C - A pair of tongs was stored on the handle for the rotisserie chicken oven and the hot hold case. Store utensils on a clean prep surface or refer to 3-304.12. CDI- Tongs were placed on a clean prep surface.
- 45 'GC: Equipment repair or replacement is necessary on: composite board shelves (water damage is causing shelving to swell and crack) and the shelves in the deli display are beginning to rust. The leg on the chicken prep sink is bent. Repair. / Milk crates are used to store food for compost. Obtain dunnage racks or other approved shelving.

- 47 Equipment cleaning is necessary on: containers used to store utensils (tongs, spatulas) and bins used to store stickers and other supplies, and the ventilation hood (grease dripping above friers).
- 49 5-202.14 Backflow Prevention Device, Design Standard - P - GC: Spray nozzle was attached to the hose next to the three compartment sink. A backflow prevention device rated for continuous pressure is necessary if the spray nozzle is going to be left on the hose after use. CDI- Spray nozzle was disconnected from the hose.
- 51 6-501.18 Cleaning of Plumbing Fixtures - C - All of the commodes in the men's and women's restrooms are soiled at the sides and back of the fixture. Clean as often as necessary.
- 52 5-501.115 Maintaining Refuse Areas and Enclosures - C - GC: There are cardboard pieces and other debris on the left side of the dumpster pad. Maintain area clean.
- 53 Floors: Flooring next to the floor drain, behind the deli case, is wearing. Repair./There are holes in the baseboard next to the handwash sink. Repair.
Walls: There are holes in the wall by the handwash sink in the prep area. Repair. / Repeat: Remove glue residue on the wall behind the 3 compartment sink.
- 54 6-303.11 Intensity-Lighting - C - Lighting in the walk in freezer is less than 1 foot candle. Lighting must be increased to at least 10 foot candles.
