Keep spray gun unscrewed or install a backflow prevention device rated for continuous pressure. / CDI- PIC removed flow valve from both canwash faucets. // 5-205.15- System Maintained in Good Repair - P - The plumbing pipe under the wash vat of the three compartment sink observed leaking. A plumbing system shall be maintained in good repair. / CDI- PIC tightened bolt that was causing the leak.
