- 8 5-202.12 Handwashing Sinks, Installation - PF- Water in deli is dispensing at a maximum of 77F through, including hand sinks. Handwashing sinks shall provide water of at least 100F through combination faucet or mixing valve. Facility in process of changing out two large water heaters in back of store, one is operational, one is unhooked. Plumbers on site. Small water heater designed to provide hot water to deli (per management) may not be operating properly. Hot water provided in other permitted areas in store. Contact city for permitting/inspection of these water heaters. Repair within 24 hours and contact Nora Sykes for verification at 336-703-3161 or sykesna@forsyth.cc
- 19 3-501.16 (A)(1) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P- Two pans of boneless wings, two pans regular wings on hot bar measured below 135F, as noted in temp log. Maintain potentially hazardous hot foods at 135F or greater at all parts of the food. REHS present during cooking and processing of these items. All measured above 135F when placed on bar. Recommend writing TPHC (time as the public health control) procedure for these items, as they are not held for more than 3 hours on the bar. TPHC rule provided. CDI-Placed these items on time for this lunch period, and they will be discarded no longer than 4 hours from removal of temperature control. Contact Nora Sykes or corporate food safety manager for any help with TPHC procedure.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P- REPEAT- Buggy of food intended for donation that had been pulled from cases and placed in walk in cooler and measured between 44-47F, as noted in temperature log. Maintain potentially hazardous foods at 41F or less at all parts of the food. CDI-Foods discarded by management. When donating food, ensure that proper temperatures are maintained.
