- 14 4-601.11 (A) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - P - Metal components of deli slicer had visible food residue on them. Food-contact surfaces of equipment and utensils shall be cleaned to sight and touch. // 4-501.114
 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P - Repeat - Quat sanitizer dispenser mounted to wall is dispensing sanitizer solution at 0 ppm. Also, all bottles checked in department measured 0 ppm. Quat sanitizers shall be 150-400 ppm. Fill spray bottles at 3-compartment sink until the wall dispenser is repaired. VR - Repair wall sanitizer dispenser by 7-25-2019 and contact Andrew Lee at (336) 703-3128 when completed.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P - Repeat - 3 rotisserie chickens in retail cooler measured 43-44F. Containers of rotisserie chickens were hanging over the edge of case by roughly half an inch possibly causing temperature rise. Potentially hazardous foods in cold holding shall measure 41F or less. CDI - Rotisserie chickens moved to walk-in cooler.
