 5-501.16 Storage Areas, Rooms and Receptacles, Capacity and Availability - C- REPEAT- The dumpster is overflowing with garbage bags. The lids will not close. Outside receptacles shall be sufficient capacity to hold refuse that accumulates.//5-502.11 Frequency-Removal - C- There are at least 30 bags of garbage stacked up in the back room ready to be placed into the dumpster but it is overflowing. REFUSE, recyclables, and returnables shall be removed from the PREMISES at a frequency that will minimize the development of objectionable odors and other conditions that attract or harbor insects and rodents. **It is recommended to increase the size of the dumpster or increase the numbers the dumpster is emptied by waste management company.
- 53 6-501.12 Cleaning, Frequency and Restrictions - C- Clean floors in the deli along the walls and in the walk in freezer. Maintain floors clean. //6-501.11 Repairing-Premises, Structures, Attachments, and Fixtures-Methods - C- There are around 16 screw anchors on the wall next to the urinal in the men's restroom. These are not easily cleanable. Maintain walls in good repair so they may be cleaned easily. *It is recommended to remove the anchors and caulk the holes.
