

Employees were recontaminating their hands after hand washing by turning off faucet handles with their bare hands. Employees shall use a clean barrier, such as a paper towel, to turn off faucet handles to avoid recontaminating their hands. CDI - Employees instructed to wash hands and did so correctly after demonstration by EHS. 0 pts.
- 14 4-601.11 (A) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - P - Repeat - Cuber blade, 11 clear plastic containers, and 10-15 lids had visible food residue on them. Food-contact surfaces of equipment and utensils shall be cleaned to sight and touch. CDI - Items taken to 3-compartment sink to be rewashed.
- 21 3-501.17 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Date Marking - PF - Repeat - Stuffed crab was prepared/opened Saturday and had no date mark. Potentially hazardous ready-to-eat foods shall be date marked if held for longer than 24 hours in the establishment. CDI - Date placed on crab case marker.

- 47 4-602.13 Nonfood Contact Surfaces - C - Repeat - Additional cleaning necessary in display case, inside microwave, on fan guards in walk-in cooler and in prep room, and on walls/ceiling of walk-in cooler. Nonfood contact surfaces shall be cleaned at a frequency necessary to maintain them clean.
