- 37 GC: The cold holding unit that is used to store condiments for hot dogs does not effectively protect food. The lids on the unit remain open unless they are manually closed. Food on display shall be protected from contamination by the use of packaging, counter, service line, or salad bar food guards; display cases or other effective means.
