Store sanitizer in containers that were not used for other chemicals. Chemical bottle was replaced with a new unused container and filled with sanitizer.
7-204.11 Sanitizers, Criteria-Chemicals - P Quat. ammonium sanitizer in the bottle was strong at >400ppm. Provide sanitizer at a strength of 200-400ppm for quat. sanitizer. Quat. sanitizer replaced and measured at 200 ppm as corrective action.
- 36 6-501.111 Controlling Pests - PF Flies present. Eliminate flies by using effective methods of pest control.
- 37 3-305.11 Food Storage-Preventing Contamination from the Premises - C Cookie in the walk-in cooler was uncovered. Keep food covered in refrigeration. Item covered as corrective action.
