

## Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 13 Ground beef and ground pork were found stored above a garlic and oil mixture. Hog casings used in the production of sausage were found stored above several ready to eat items. Keep all food items stacked on shelves in refrigeration units in order of final cook temperature. E.G. (from bottom to top shelves) poultry, comminuted meats (ex ground beef), beef, pork, shell eggs, seafood, cooked / ready to eat / vegetables.
  
- 14 Cleaning is needed on the interior of the ice machine. The dish machine was not sanitizing properly at the time of this inspection. Until the needed repairs can be made utensils will be washed, rinsed, and sanitized in the 3 compartment sink.
  
- 45 The screws used to mount the can openers to the prep tables throughout the facility are too long. Either shorten the screws (no more then a 2 threads should be exposed) or cover them with caps so that they are easily cleanable. items were found stored on unapproved shelving in the upstairs storage area and on milk crates in the walk in freezer. All shelving must meet NSF standards of being smooth and easily cleanable.
  
- 53 Repair the chipped damaged finish on the floor in walk in cooler 2. The second floor storage area is not constructed to be easily cleanable. This area needs to be constructed so that it is easily cleanable.
