- 1 2-102.12 Certified Food Protection Manager - C- REPEAT- The establishment did not a have certified food protection manager on-site during the inspection- At least one employee who has supervisory and management responsibility and the authority to direct and control food preparation and service shall be a certified food protection manager who has shown proficiency of required information through passing a test that is part of an American National Standards Institute (ANSI) accredited program.

- 6 2-301.12 Cleaning Procedure - P- One food employee completed a handwashing step but used her bare, washed hands to turn off the faucet and dispense the disposable hand drying towel- Food employees shall wash their hands after engaging in activities that contaminate the hands and to avoid recontaminating their hands or surrogate prosthetic devices, food employees shall use a barrier such as disposable towels to turn off manually operated faucet handles on a handwashing sink or on the handle of a restroom door and to dispense additional disposable hand drying towels-CDI: The employee rewashed her hands using an approved method- 0 pts.



- 14 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P- The establishment did not have test strips available to determine if their sanitizing solution met the approved concentration level for effective use. - 19 3-501.16 (A)(1) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P- The following items were found out of temperature control on the roller grill: Hot dogs 110-114F, Cheedarwursts 111- 115F, Polish sausage 111-115F chicken tornado 110F, Cheese-pepperoni tornado 110F- Potential hazardous foods shall be maintained at 135F or above-CDI: All items were reheated to 165F or above.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P- The following items were found out of temperature control in the sandwich cooler: Sausage, egg and cheese sandwich 43F, Boneless BBQ sandwich 45, Cheeseburger 45F- CDI: All items were voluntarily discarded by the person-in-charge- 0 pts.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C- REPEAT- Reach-in cooler has rusting shelves, the lower shelves and legs on shelf for the doughnut ingredients are rusting and need to be reconditioned or replaced. The door to the under counter cabinet at the Dunkin express station is broken and needs to be repaired- Equipment shall be maintained in a state of good repair.
- 46 4-302.14 Sanitizing Solutions, Testing Devices - PF- The establishment did not have test strips available for use to measure the sanitizing solution in the three compartment sink- A test kit or other device that accurately measures the concentration in ppm of sanitizing solutions shall be provided- CDI: The PIC obtained approved test strips from another local Speedway location- 0 pts.
- 52 5-501.15 Outside Receptacles - C- REPEAT- The door to the outside dumpster was left open- Receptacles and waste handling units for refuse, recyclables and returnables shall be kept covered with tight-fitting lids or doors if kept outside of the food establishment.
- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - C- REPEAT- Seal the hole in the ceiling where the soda lines enter from the bag and box syrup system. Repair cracked caulking at the junction between the white porcelain handwashing sink and the wall, remove the excess caulking and provide a smooth and easily cleanable surface at the junction between the 3 compartment sink and the wall, provide a cover for the hole in the wall inside of the mens restroom at the water access line and repair the broken floor tile- Physical facilities shall be maintained in good repair.
