- 14 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P - No sanitizer present at beginning of inspection, manager filled bottle with sanitizer - Sanitizer not dispensing properly - did not register on test strips - chemical company called during inspection but did not arrive - quat sanitizer must dispense properly to be able to register between 200 - 300 ppm - sanitizer manually made until dispenser is repaired - will follow up visit/contact within 10 days to verify item is corrected
- 26 7-201.11 Separation-Storage - P - Bottles of chemicals stored on front handsink - all chemicals must not be stored on handsinks - manager moved chemicals to bottom shelving below handsink
- 38 2-402.11 Effectiveness-Hair Restraints - C - Manager prepared tornados for customer without hair restraint - employees must wear effective hair restraint while in food prep areas
- 47 4-602.13 Nonfood Contact Surfaces - C - Slight debris build-up in condiment bins - clean out as often as necessary so bins are free from build-up
- 49 5-205.15 System Maintained in Good Repair - P - Slow drain in women's restroom handsink - clear line so water adequately drains in handsink
- 52 5-501.15 Outside Receptacles - C - Dumpster doors and cardboard dumpster lid open - shut dumpster doors when not in use as to help prevent against pest and rodent harborage
