- 37 3-305.11 Food Storage-Preventing Contamination from the Premises - C Many containers of pizza sauce stored on floor. Store food in a clean, dry location, not exposed to contamination. Keep at least 6 inches above the floor.

- 41 3-304.12 In-Use Utensils, Between-Use Storage - C Ice scoop stored on top of ice machine. Store in-use utensils in a clean, dry place, in food with handles out, in 135F or greater water or in running water which quickly moves food particles to the drain.

- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repeat violation. Recaulk hoods where sealant has deteriorated. Replace rusted/damaged racks in refrigeration units. Equipment shall be in good repair.
